Lakemary is excited to announce the appointment of Dr. Lauren Richter OTD, OTR/L, CLT as the new Director of Risk Management.



In this role Dr. Richter will lead the entire risk assessment process, which includes report reviews, investigations, findings, and recommendations for performance improvement. This position chairs the Risk Management Committee and trends risk management data at Lakemary. She will oversee the risk management and safety programs ensuring policies, procedures, standards/regulations, and organizational goals are being met.

Dr. Richter is an occupational therapy practitioner with a wide variety of clinical, community-based practice, and leadership experience supporting individuals with special needs across the lifespan. Her passion is serving individuals of all abilities through building relationships and developing innovative programming while empowering others to do the same.

She attended the University of Kansas for undergraduate degree work in Psychology and participated in work opportunities as a paraprofessional and direct support worker. Dr. Richter earned her Masters of Science in Occupational Therapy from the University of Kansas Medical Center in 2016 and began

her career working full-time for a local school district, serving children and adolescents grades K-12. In 2018, Dr. Richter shifted from direct OT practice to a program development role to build a collaborative, life skills program for high school students. In addition to school-based practice, she has dedicated time to supporting clients and families in outpatient pediatrics, a residential psychiatric facility, inpatient rehabilitation, and acute care.

In May 2021, Dr. Richter graduated with her post-professional, Doctor of Occupational Therapy degree from Creighton University. After earning her OTD, she began working as an adjunct faculty member at Rockhurst University and continued providing community-based and home health occupational therapy services to children and adults with a variety of medical diagnoses and needs. She is excited to be joining the Lakemary Center team as Director of Risk Management and Occupational Therapy.

KDHE RECYCLING Grant

KANSAS DEPARTMENT OF HEALTH AND ENVIRONMENT

Lakemary's Business Solutions program keeps its workforce of adults with special needs busy throughout the year and recycles an average of 41 tons of paper and 18 tons of electronic waste annually. This program - founded in 2004 - serves corporate clients as well as individuals and families throughout Miami and Johnson counties. Unlike other recyclers, Lakemary offers pick-up services and drop-off options in locations in Paola and Olathe.

Recycling efforts expand each year, both in regard to the amount of recycled materials averted from landfills, but also in the number of clients served. A grant this year from the Kansas Department of Health and Environment will augment the program's growth by providing funds to purchase two new industrial shredders to replace antiquated models and additional shelving and steel carts to improve efficiencies.

"We are grateful for the continued support of the Kansas Department of Health and Environment," said Miranda Kranz, Director of Adult Services for Lakemary. "This is the second time Lakemary has received a grant from KDHE. Their financial support has helped significantly grow our program which in turn encourages others to recycle, lessens the burden on local landfills and helps the environment – all while providing employment opportunities for adults with special needs."
