

Fiscal Year July 1, 2021 to June 30, 2022





CHILDREN'S SERVICES

LAKEMARY SCHOOL - 100 students attended Lakemary's school each day. The impact our teachers continue to have on our students is tremendous. We proudly graduated seven students from the Lakemary School in May. We hosted the graduation ceremony and reception for quests.

Krystal Lofing was nominated as a Teacher of the Year candidate for USD 368, she also completed her 25th year at Lakemary.

Through a generous grant from First Option Bank, 30 new school iPads are being used for daily classroom activities and state testing. We also finished our first year with our Promethean boards. These innovative touch screens help the educational needs of every child at Lakemary. It has been exciting to see every child using these at their ability level.

AIM - This is a new addition to the Lakemary School. This educational program is solely focused on increasing independent living skills and vocational training for children that have achieved all the necessary academic credits to graduate high school, ages 18-21. The goal is to help our children leave Lakemarywith the skills to be as independent as possible. Much of the program occurs in the community where real-life training can occur either through vocational training opportunities or learning how to shop, order in a restaurant, check out a book at a library, etc. As we grow this program we are hoping to continue to develop more vocational



opportunities and more partnerships with community organizations.

cultural awareness - Over the past year, a cross-divisional team have worked together on increasing cultural awareness of different countries. A different country is the focus each month. Our dietician and her team have worked to add special meals for each country into the menu while our teachers and therapists have also added educational and therapeutic opportunities about each culture into their sessions.

MEDICAL - Our focus was on overall wellness and prevention throughout the year. This includes educating staff and children on the importance of a well-balanced diet, hydration, and exercise. With our clinical department, we also worked with Pittsburgh State University to implement a Wellness Warriors program during the past year. The children benefited from this program and participated in activities throughout the year. We plan to continue this program through our wellness program in 2023.

THE RANCH - A favorite of our students and staff, the Lakemary Ranch continues to provide therapy and learning opportunities for our children. We welcomed a new Nigerian Dwarf goat to the Ranch this year and "Julius" has been a highlight for the children. Patricia Wolfe and her team continue to bring new ways of learning with the animals, greenhouse, and garden areas during the year.



We partnered with the building committee in the development of our new Psychiatric Residental Treatment Center that broke ground in November. The IMPACT this new building will have on our children and our team will be recognized for many decades to come. We are looking forward to being able to offer our children their own rooms, playrooms, therapy areas, and outdoor learning spaces. This new building will provide our staff with a state-of-the-art building for working with the children we support.

ADULT SERVICES



ADULT SERVICES PROGRAM - have a renewed sense of excitement as we begin to again pursue opportunities for community activities, work, and enrichment. We returned to many of our favorite activities this year. We recently held our first Kansas Special Olympic event since 2020, and we enjoyed the long-awaited return of the family picnics and our annual Talent Show this fall. The holidays were full of activities, bringing joy to the adults we support. Residential leadership is excited about their new initiative to enhance communications through our weekly email blasts, newsletters, and more.

On the program side, we developed the Specialized Aging Support Services (SASS) program which was conceptualized prepandemic. Through this program, people experiencing challenges directly related to the aging process will receive targeted support from SASS Team members.

We recently completed a transition within the Organizational Employment Department from a per-piece pay structure to an hourly wage model. This ensures each person working makes at least minimum wage, but often above that rate. New work opportunities for people working within the day Organizational Employment program continue to be an area of focus.

Our Health Services team has been an essential partner in the development of the Specialized Again Support Services Program (SASS). In addition to supporting annual flu clinics, this department has expanded its capacity by opening referrals to include people who receive only day services and now provides them essential health assessments for 70 people.

THE KINDNESS CREW VOLUNTEER PROGRAM



Lakemary Golf Classic 2022





NEW PSYCHIATRIC RESIDENTIAL TREATMENT FACILITY



The Board of Directors, Executive Team, and Capital Campaign Committee are pleased to announce the groundbreaking of our new psychiatric residential treatment facility on our campus in Paola. "We have been working diligently over the past year on a plan to build a new facility on our campus for the children we support and for our team of employees," says Mike Sanders, Board Chair.

The new building will include 40 individual bedrooms, therapy rooms, a dining room, playrooms as well as a library, a media center as well as other amenities for the children and our staff. "Lakemary has had many years of providing care and treatment to the children we support and today the need is even greater. More and more children need a psychiatric treatment facility that also allows for intellectual and developmental disabilities," explains Kirk Davis.

The Blueprint for HOPE capital campaign has kicked off with Dr. Bill Craig and Lonnie King cochairs. The goal of the A Blueprint for HOPE campaign is to raise \$16M to pay for the new PRTF building in Paola.

"This is an exciting addition to Lakemary and we are looking forward to sharing the plan and the impact this building will have on our children and staff with existing and new donors," says Teddi Hernandez.
