## What is a living trust?

- It's a legal agreement giving your property to a trust, along with directions on how to distribute the assets
- A living trust allows your loved ones to inherit your assets without going through probate
- Probate is a court process that determines who inherits your property when you pass away. It can be costly and very time-consuming
- You are the trustee while alive and will continue to control your property as usual
- When you pass, your trustee must manage the assets according to the directions outlined in the living trust
- Because the trust — and not you — owns the property, there's no need for probate

## What is a pour-over will?

- It's a special type of last will and testament for someone with a living trust
- Assets (such as cash, bank accounts and real estate) will be transferred to your living trust while you're alive
- A pour-over will takes care of anything not already named in the trust when you die. It simplifies the probate process for your remaining assets

## What does a pour-over will do?

- It appoints a personal representative, or executor, to oversee your estate settlement
- It names a guardian for any minor or disabled children
- It sets aside money to care for your pets
- It gives specific items as a gift to specific people
- It tells the probate court that you want the left-over assets outside of your trust to be given to the trust when you pass away
- It saves time and money because the (probate) court only oversees the transfer of a few assets to one beneficiary — the trust
